CREDIT ACCOUNT AGREEMENT:

2. Checker Cabs Ltd. reserves the right to amend or change the provisions, terms and conditions of this agreement at any time by mailing to the credit holder written notice of such amendments or modifications.
3. Checker Cabs Ltd. reserves the right to withhold further credit to any credit holder, once the credit limit of the account is reached.
4. Any change of name or address, or other particular changes, must be reported to Checker Cabs Ltd. immediately.

NOTE: FURTHER PROVISIONS APPLY TO CHARGE CARD MEMBERS:

5. The Checker Cabs Ltd. charge card is not transferable nor assignable.
6. The charge card remains property of Checker Cabs Ltd., and the card may be revoked at any time without prior notice by Checker Cabs Ltd. Any card revoked must be surrendered immediately upon demand from Checker Cabs Ltd.
7. The cardholder is liable to all charges made with the charge card, whether such use is by the cardholder or any other person with or without the authorization of the cardholder.
